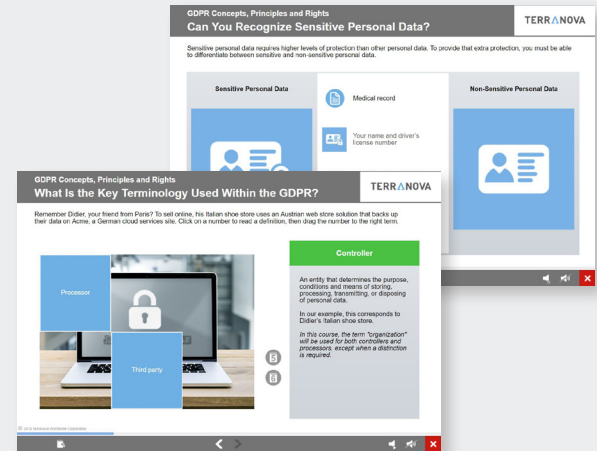


PRIVACY AWARENESS

GENERAL DATA PROTECTION REGULATION (GDPR)

The General Data Protection Regulation (GDPR) that has taken effect on May 25th, 2018, requires that your employees be trained and knowledgeable (articles 39, 47). This regulation applies to all organizations that process the personal data of data subjects residing in the European Union (EU), regardless of the organization's geographical location. It also applies to the processing of anyone's personal data when the processing is performed in the EU. The GDPR aims to harmonize privacy laws across the EU, strengthening the protection of personal information and protect individuals from privacy breaches.

GDPR Key Concepts, Principles, and Rights

The target audience is most employees in an organization but more specifically:

- Those who create, read, update, delete or process the personal data of EU data subjects.
- Those that process personal data, regardless of country of residence of the data subjects, where that processing occurs within the EU.

GDPR for Managers

The target audience includes managers, leaders, and decision makers who need to understand how the GDPR applies to their work in order to ensure that any policies, procedures or other documents within their departments are in compliance.

The target audience includes IT development, IT operations, and IT Security – especially the following functions with access to personal data storage, processing or transmission:

- Those involved in any phase of the Software Development Life Cycle (SDLC)
Plan → Design → Build → Test → Rollout → Maintain
- Database Administrators
- CT Administrators
- Those in IT who outsource processing of personal data to 3rd parties

GDPR for Procurement Employees

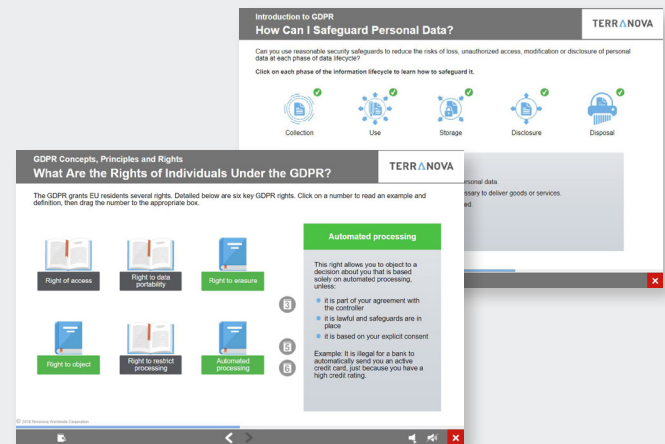
The target audience includes those who write, collaborate on, negotiate, or authorize contracts for the processing of personal data, especially the following functions:

- IT Contract Negotiators
- Labor Contract Negotiators
- Customer Contract Negotiators
- Legal
- Information Security
- Compliance
- Internal Audit

GDPR for Retail, Sales & Marketing

The target audience includes anyone involved in the following functions:

- Retail activities involving direct interactions with the customer, whether online or face-to-face
- Marketing, sales, and customer account activities aimed at informing existing or potential buyers
- Customer and aftersales support services provided to customers after they purchase the goods or services



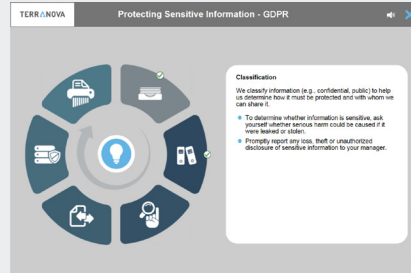

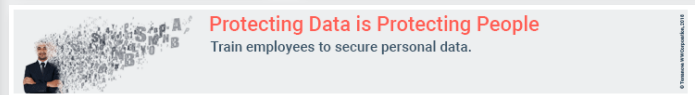
